Ordinance #1024, Setting the Tax Rate for 2020

Upon motion by Brooks, seconded by Rose, Council unanimously approved Ordinance #1024 setting the tax rate for the year 2020 at 4.75 mills for the general purposes and 1.5 mills for fire protection purposes.

Consider Resolution #2019-32, Approval of Final Budget

Upon motion by Faulkner, seconded by Rose, Council unanimously approved Resolution #2019-32, adoption of the 2020 budget for all funds.

Consider Resolution #2019-30, 2020 Wage Schedule

Upon motion by Rose, seconded by Faulkner, Council unanimously approved Resolution #2019-30, establishing the wage and salary schedule for the year 2020 for all non-uniformed employees.

Consider Resolution #2019-31, Consolidated Fee Schedule

Upon motion by Brooks, seconded by Faulkner, Council unanimously approved Resolution #2019-31 to establish a new consolidated fee schedule for the year 2020, effective January 1, 2020.

Consider Opening New Account-Covered Bridge Donations

Upon motion by Faulkner, seconded by Purcell, Council unanimously established a new bank account to handle donation and expenses associated with the restoration of the covered bridge in Lenape Park.

Consider Appointment of Auditor to Perform the 2019 Audit

Upon motion by Faulkner, seconded by Rose, Council unanimously approved the quote from Styer Associates for audit services for the 2019 fiscal year at a cost of \$15,705.

Consider Resolution #2019-35, Airport Escrow Release

Upon motion by Clark, seconded by Faulkner, Council unanimously approved Resolution #2019-35 to authorize a reduction in the escrow for the Pennridge Airport Business Park Lot 2 as approved by Gilmore and Associates, Inc in the amount of \$134,667.0 to reduce the total escrow to \$531,129.52 and to authorize the signature of the Borough Manager on the escrow reduction.

Consider Close Security Deposit Account Cliff Capital Management

Upon motion by Rose, seconded by Purcell, Council authorized the closing of the security deposit account for Cliff Capital Management and to transfer the remaining balance to the general fund.

Consider Resolution #2019-34 Escrow Release 40 North Main Street

Upon motion by Faulkner, seconded by Purcell, Council unanimously approved Resolution #2019-34, a resolution of the Borough Council authorizing a reduction in the escrow for the single family construction project at 40 North Main Street as approved by Gilmore and Associates, Inc. and authorizing the return of any remaining escrow balance to the applicant.
