Consider 2021 Road Condition Survey

Upon motion by Purcell, seconded by Bomboy, Council unanimously approved the 2021 roadway condition survey and the 5 to 15 year reconstruction plan.

Discuss 4th Street Traffic Calming Measures

Council discussed 4th Street calming measures. Upon the recommendation of the traffic engineer Damon Drummond, Borough Council agreed to try speed cushions on South 3rd Street and Park Avenue first and then take action if S 4th Street sees an unacceptable increase in traffic volume.

Resolution #2021-44, a resolution authorizing the conversion of all or a portion of the general obligation notes 2002, 2006, and 2007 series (collectively, the "Participant note") issued by the Borough of Perkasie ("the Participant") to a loan fixed rate and the repeal of any inconsistent resolutions; the Borough Manager is authorized to lock in the interest rate and proceed with the refinance if the rate is within +0.25 of the above Friday's rate.

Consider Upgrade to Phone System

Upon motion by Rose, seconded by Pizzollo, Council unanimously authorized the solicitor to draft an approval resolution for sales quote #28390 with ET&T for the purchase and installation of a Mitel Mivoice Business 3300CXi platform system.

Resolution #2021-45, Escrow Release 208 Ridge Avenue

Upon motion by Clark, seconded by Pizzollo, Council unanimously approved Resolution #2021-45, a resolution of the Borough of Perkasie authorizing a reduction in the escrow for the 208 Ridge Avenue project as approved by Gilmore & Associates Inc., in the amount of \$10,792.49 to reduce the total escrow to \$9,207.51 and authorizing the signature of the Borough Manager on the escrow reduction.
