Zoning Hearing Board Report

The applicant is requesting a variance to construct a single family variance residential dwelling with a porch, deck, walkway and driveway connecting to the existing driveway along the western property line with access to North Ridge Road. Discuss Adding No Parking Zones; East Walnut Street Alleys

Upon motion by Purcell, seconded by Faulkner, Council authorized the Borough Solicitor to draft an ordinance to assign a no parking zone along East Walnut Street within 20 feet of two alleys between Virginia Avenue and S. Main Street.

Consider Ordinance #1043, Stop Signs/Yield Signs

Upon motion by Faulkner, seconded by Purcell, Council agree to table the ordinance pending PennDOT approval. The Ordinance will be put on the August 1, 2022 Council agenda.

Consider Ordinance #1045 Amending the Zoning Ordinance for Mixed Use Buildings

Upon motion by Ryder, seconded by Faulkner, Council unanimously approved Ordinance #1045, amending the Perkasie Borough Code of Ordinances so to amend the Zoning Ordinance, use regulations and restrictions, related to mixed use regulation not included in the Town Center Overlay District and off-street parking and loading related to mixed use parking.

Consider Ordinance #1046, Amending the Zoning Ordinance to Allow Outdoor Seating

Upon motion by Brooks, seconded by Purcell, Council unanimously approved Ordinance #1046, amending the Perkasie Borough Code of Ordinances to amend the use regulation and restrictions for accessory uses, so as to add outdoor seating provisions.
