**CONSOLIDATED FEE SCHEDULE**

WHEREAS, the Borough of Perkasio charges fees for various services provided and applications made to the Borough; and

WHEREAS, Borough Council wishes to adopt a consolidated schedule of fees for these services;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Perkasio that the following consolidated schedule of fees is adopted for the year 2012, and shall remain in effect until further amended.

**FEES**

**1. BUILDING FEES**

In addition to the fees below, all building and construction permits will include a \$4.00 administrative and enforcement fee.

Single and/or Multi Family Dwelling Unit - Basic fee-\$500.00 per dwelling unit plus \$ .30 per square foot.

Additions/Garages/Accessory Buildings - Basic Fee-\$125.00\*; plus \$.25 per square foot, all areas

\* Area calculations shall be made using outside dimensions of construction for all usable areas (per floor) including patios, decks, porches, basements, crawl spaces, and garages. For a utility shed under 120 sq.ft., no building permit is required. (See zoning permit.).

Alterations/Repairs - \$100.00 plus \$.35 per square foot

Electrical Permits - Basic Fee - \$35 for first \$100.00 of valuation; \$5.00 for every \$100.00 of valuation thereafter.

Plumbing Permits – Residential \$100 up to three (3) fixtures, plus \$7.50 per fixture thereafter

Mechanical Permits - \$100 for the 1<sup>st</sup> \$1,000 in valuation, \$15.00 for every \$1,000.00 in valuation thereafter.

Nonresidential - New - Basic fee \$500.00 plus \$ .35 per square foot plus \$100.00 use and occupancy permit per unit within building, Alterations - \$600.00 for first 1000 square foot \$200 per 1000 square foot additional except that for work valued under \$5,000 there shall be a fee cap of 10% of the total cost of construction and a minimum fee of \$50.

Penalty Fee - In the event construction is started without first obtaining the required permits, the applicable fees will be increased by 100%.
