Upon motion by Aigeldinger, seconded by Pizzollo, Council considered indefinitely postponing the matter. Councilmembers Clark, Bomboy, Aigeldinger and Pizzollo voted to indefinitely postpone. Councilmembers Ryder, Purcell, Brooks, and Rose voted not to indefinitely postpone. The vote was tied 4-4. Upon motion by Ryder, seconded by Purcell, Council considered rejecting the proposal submitted by U.S. Municipal Supply Inc. for a Street Sweeper in response to bid #2017-06 for a bid price of \$80,000. All Councilmembers voted in favor of the motion with the exception of Brooks who voted No.
