Update on 1208 Tunnel Road

The Solicitor updated Council on the results of the upset sale at 1209 Tunnel Road that occurred on June 14. The bid price was \$73,000. The Borough will get about \$35,000 back in reimbursable fees such as mowing and property clean up. The neighbors are reasonably happy with the clean-up.

PERSONNEL AND POLICY COMMITTEE

Consider Resolution to Update Police Pension Plan

Upon motion by Aigeldinger, seconded by Purcell, Council unanimously authorized the Solicitor to draft an amendment to the Collective Bargaining Agreement between the Borough of Perkasie and the Perkasie Police Officer's Association for a term of one year with a wage increase of 3.5%, an increase in the life insurance benefit to \$250,000 per covered life, and a change in the pension plan allowing a pre-retirement death benefit after 22 years of credit service. Additionally, authorizing the solicitor to advertise a public hearing for the August public meeting for the changes to the pension plan.

Consider Compensation for Interim Chief of Police

Upon motion by Purcell, seconded by Clark, Council unanimously approved additional compensation of \$1,200 per month above the regular salary for detective Sergeant Russ Closs while acting in the Capacity of the Interim Chief of Police. There will be no overtime compensation paid during this period.

Consider Motion to Concur with Borough Manager Decision to Hire Public Works Employee

Upon motion by Purcell, seconded by Pizzollo, Council unanimously approved the Borough Manager's recommendation to hire Tylor Delikat to the position of part-time Public Works Laborer.

Consider Motion to Concur with Borough Manager's Decision to Hire Pool Manager

Upon motion by Ryder, seconded by Faulkner, Council unanimously concurred with the Borough Manager's decisions to hire Ashley Gross as pool manager.

Consider Acceptance of Electric Department Foreman Resignation

Upon motion by Brooks, seconded by Purcell, Council unanimously approved the resignation of resignation of Fred Schutte effective July 11, 2019.
