Consider Bid #2021-2, 2021 Road Program

Upon motion by Purcell, seconded by Aigeldinger, Council unanimously awarded Bid #2021-2 to Harris Blacktopping, Inc. the lowest responsible bidder, with a base bid amount of \$339,955.25, alternate #1-5 total \$212,841.25, for a total contract cost not to exceed \$552,796.50.

Consider Bid #2021-3, Concrete

Upon motion by Rose, seconded by Pizzollo, Council unanimously awarded Bid #2021-3

to T. Schiefer Contractors, Inc., the lowest responsible bidder, with a base bid amount of \$80,082, alternate #1 \$58,359, and alternate #2 \$16,174 for a total contract price not to exceed \$154,615.
